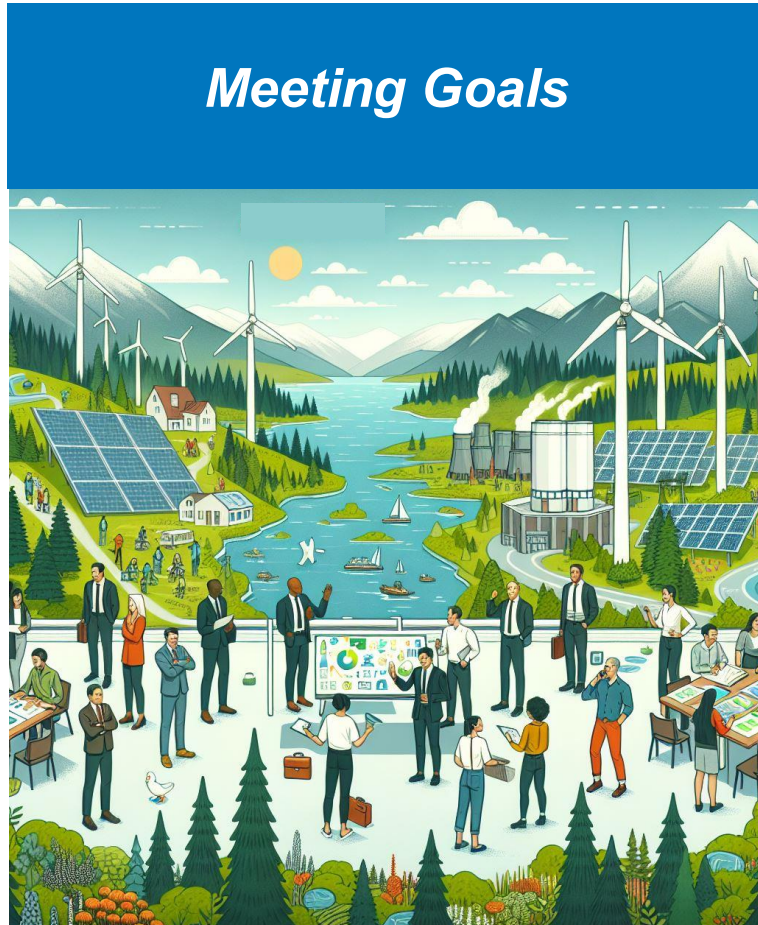

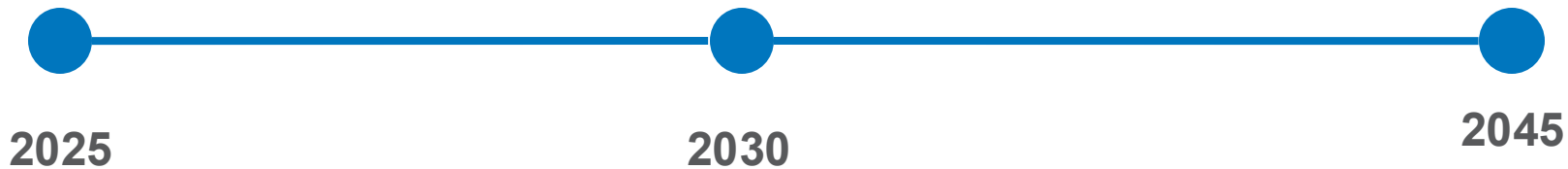

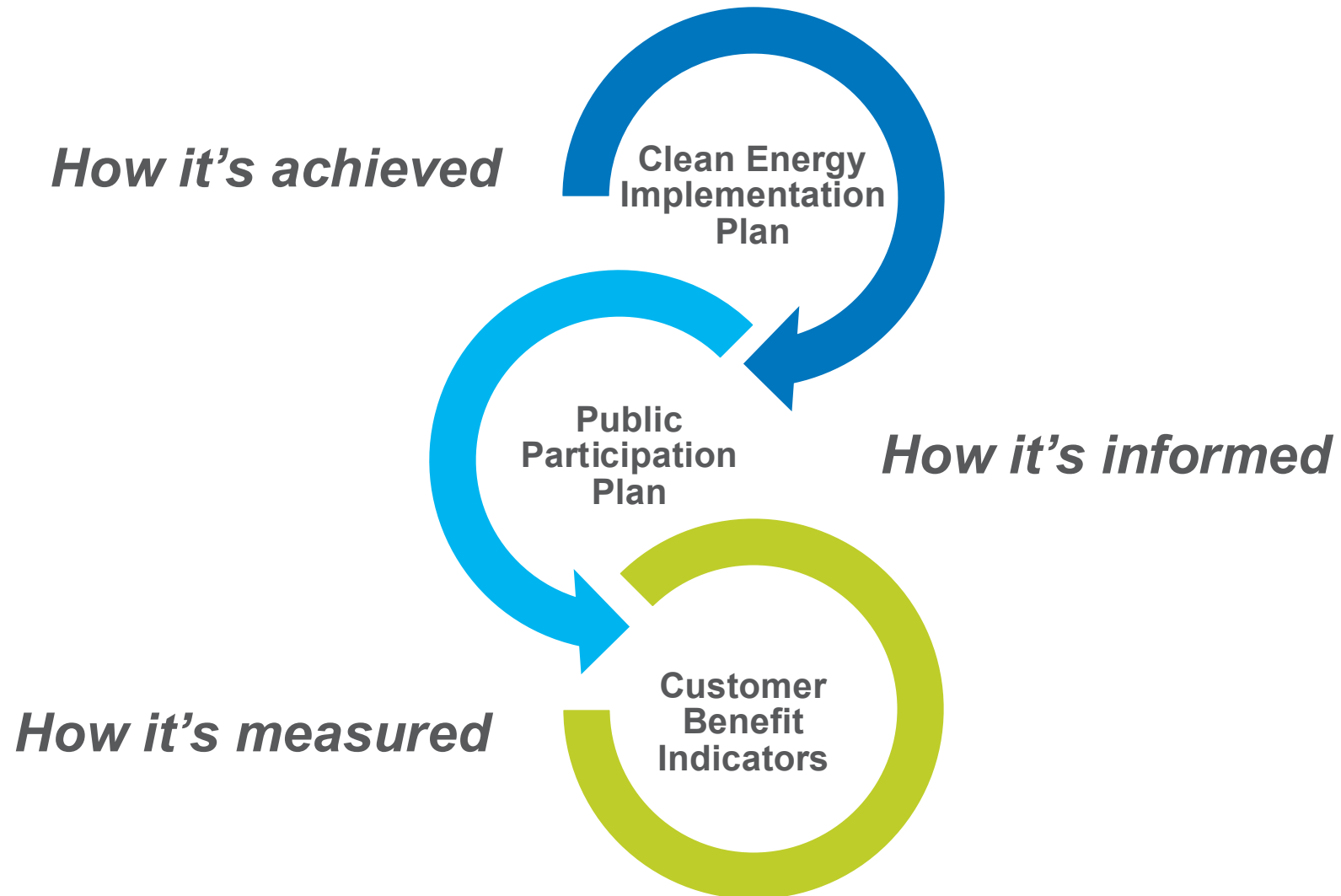
Use of carbon-neutral

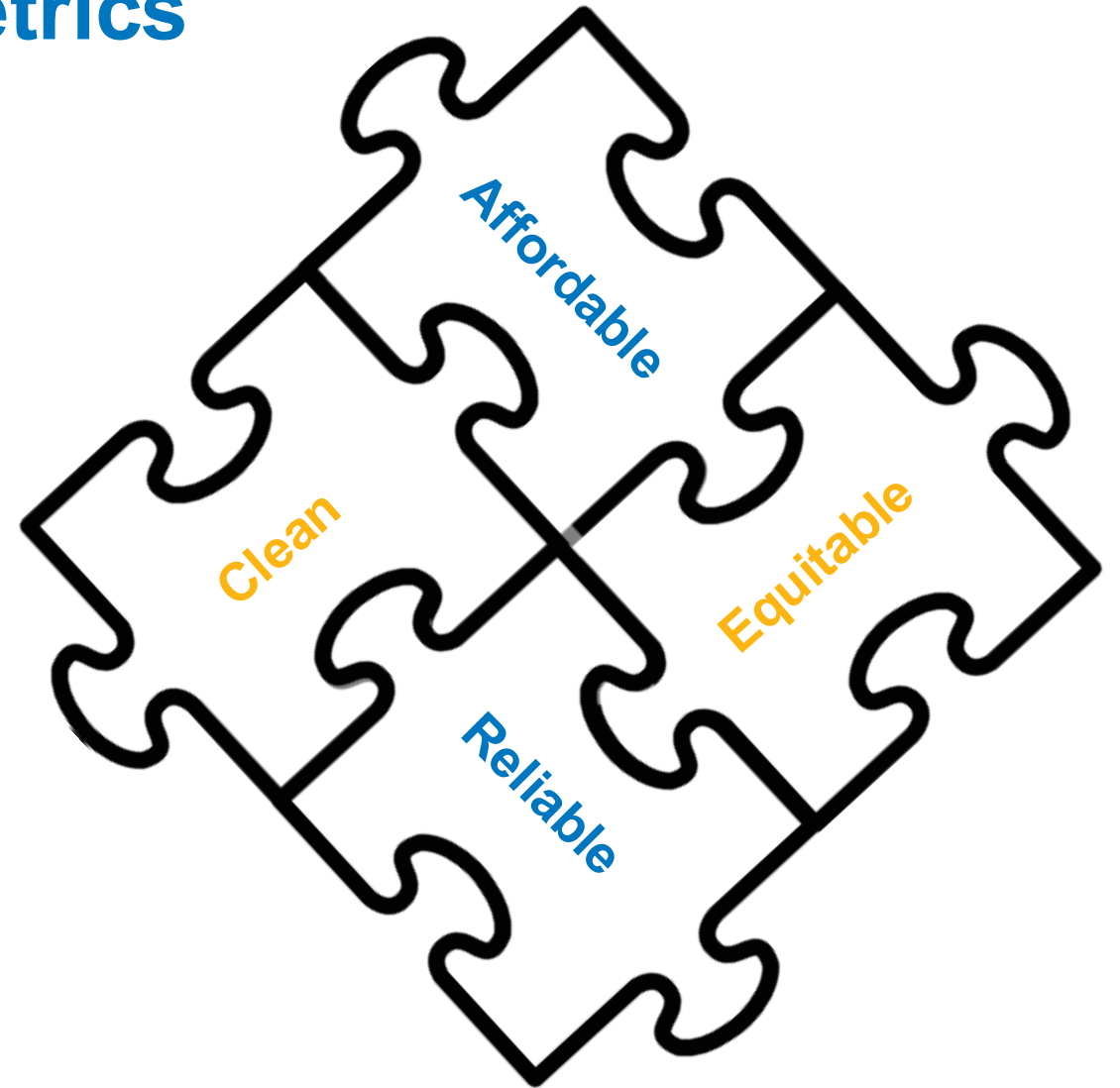
