Dear Avista Customer:

Avista recently completed our annual evaluation of energy savings, market costs and other considerations associated with our **Commercial Energy Efficiency programs**. This analysis resulted in some changes to incentive amounts and may include measure discontinuations and additions. The new Commercial Incentive Agreements will be made available online just prior to **January 1, 2025** when the changes go into effect. To receive 2024 measures and incentive amounts, measures must be installed and operating; an Avista agreement form, final invoices and other required documentation must be submitted and postmarked to Avista no later than **December 31, 2024**. Any applications submitted prior to this date will not be held and will receive the 2024 program offerings. Any applications submitted after this date will receive the revised 2025 offerings, if applicable.
