This results in an annual increase in revenue of approximately \$13,578,000. In addition, the Commission approved an increase in LIRAP funding of approximately \$651,000. The Commission also implemented a rebate returning tax benefits of \$58,100,000. The tax rebate will fully offset the revenue increases in base rates and LIRAP for two years and any remaining balance will be rebated to customers over a 10-year period, subject to reexamination by the Commission in Avista's next General Rate Case.
